

# Alternative Suspects and Evidence Supporting Their Involvement in the Double Murder

## SUSPECT A

### ANONYMOUS CALLER

Reported "SUSPECT A" as a shooter wearing "a wig or some disguise"

Reported "SUSPECT A" wanted HUBERT killed to stop him from reporting that he killed Emuel Bowers in 2010. *Hambrick Email, 2011; App. 48.*

### TRIAL TESTIMONY

The Waco Police Detective who investigated Bowers' murder considered "SUSPECT A" as a suspect. *30 RR 178-79; App. 1-2.*

"SUSPECT A" had been negotiating a marijuana transaction with BOWERS in the days prior to BOWERS' murder. *30 RR 80-83.*

## SUSPECT B

### ANONYMOUS CALLER

Reported "SUSPECT B" as a shooter, was wearing a red hoodie, and lived in the Villa Apartments.

Also reported "SUSPECT B" was a shooter on 3/2 when Erma Richards (Cummings' Grandmother) was shot. *Hambrick Email, 2011; App. 48.*

### WITNESS #1 STATEMENT

Saw 2 men with red hoodies and black masks pull out guns, walk to the car, and start shooting.

Heard someone say "come on [SUSPECT B]", after the shooting and saw the men run out of the front gates of the apartment complex. *Moten Aff. 2011; App. 414, App. 415-416.*

### WITNESS #2 STATEMENT

Warned by her sister to "get away from" her boyfriend "SUSPECT B" after the murders because he was "the shooter". *App. 416*

### WITNESS #3 STATEMENT

Heard NICKOLL HENRY (key witness) telling people in the crowd after the shooting "I know who did this" and that SUSPECT B had killed "Lockie" and other people in the car. *Harrison Dec 2019; App. 420.*

## SUSPECT C

### ANONYMOUS CALLER

Reported "SUSPECT C" as wearing a red hoodie and shooting the AK-47 and "lives in or lived in" Apt #8 but was staying in Apt #200 on 3/28. *Hambrick Email, 2011; App. 48*

Reported "SUSPECT C" alias as [REDACTED] and shot Erma Richards (Cummings' Grandmother) with the same AK-47. *Hambrick Email, 2011; App. 48*

### MAINTENANCE WORKER & VILLA'S MANAGER

Identified "Suspect C" as shooter of Erma Richards on 3/2/2011 with large caliber rifle. *App. 7-9*

### TRIAL TESTIMONY

Apt #8 is adjacent to the breezeway where Witness #4 saw three men (one wearing red and toting a big gun) just prior to the double-murder.

Apt #8 is near the spot in the fence that had been pulled open where Witness #4 saw the three men. *32 RR 213-15, 33 RR 45-47.*

**Ballistic comparison of 7.62x39 casings from 3/2 shooting (injuring Cummings' Grandmother) and 3/28 double murder shows possible match. *App. 55.***
